Terms and Conditions

By entering or agreeing to participate in the Locality Awards, all entrants agree to the terms and conditions below.

Eligibility

- To be eligible for all Locality Awards, organisations must be Locality Members with an Essentials or Membership Plus package.
- All shortlisted applicants should be prepared to send in some photos that will be used during the Awards ceremony at the Locality Convention '26 on 1 December 2026.
- Three finalists will be selected in each category and invited to the Locality Awards dinner to take place at Locality Convention '26 on 1 December 2026 at the Mattioli Woods Welford Road Stadium in Leicester.
- Winners will be announced during the dinner at Locality Convention '26. All finalists will receive **one** free ticket to the Locality Awards dinner and are eligible for a £50 discount off their overall Locality Convention '26 ticket if they wish to attend the full event.
- Each award-winning community organisation will receive a cash prize of £1000 to invest into their community or organisation, and this will be paid to the winning organisation account only.
- The judges' decision is final and binding.

Nominations/Applications

- Individuals nominating an organisation must complete and submit the nomination form available online.
- **The nomination deadline is 1 July 2026.** Any nominations submitted after this date will not be considered for an award.
- Organisations can enter or be entered in more than one award category but can only win one award.
- If you are thinking of nominating an organisation, please contact the relevant person first and seek their permission for the nomination. Please also provide a contact email and let the relevant person know that if their organisation is shortlisted, we will contact the nominee by email.
- Locality assume no responsibility for errors in transmission, interruptions in service, or other technical errors or delays which could affect a given applicant's submission. A confirmation of reception will be sent within seven days of reception of the application. - We reserve the right, after consultation with the individuals nominating and/or the nominees, to move submissions to a more appropriate category if necessary.
- We reserve the right to withdraw an entry from the judging process at any time if the entry is deemed inappropriate for any reason.



- If it is found that any entrant has knowingly provided false information on their application for their entry, we reserve the right to withdraw any award at any time submitted by that organisation.

Your data
